Andrea Thielk, President's Report:

It's been a whirlwind of excitement as this year's president of BIAWE. With BIAWE's Mission of AWARENESS, EDUCATION AND SUPPORT, we added new programs to BIAWE's portfolio of events, programs and services.

AWARENESS: New this year, BIAWE raised awareness in the community through the following exciting events:

<u>NEW</u> Unmasking Brain Injury - Survivors painted and unveiled masks at the **Art Gallery of Windsor**, part of an Ontariowide initiative of **OBIA**. We received a generous grant from **Rotary Club of Windsor (1918)** to cover the costs of this project. These masks which visually show the feelings of survivors are displayed all over the city and county, and videos were produced promoting the event.

<u>NEW Medical Scripts and Information Packages</u> -These prescription pads and information packages were sent to health care professionals to refer people with ABI to our programs and services.

Executive Director, Anna Jurak, continued the BIAWE awareness through undertaking the following activities:

<u>"Step Ahead" Newsletter</u> published by **Anna Jurak** quarterly and distributed by email to all OBIA/BIAWE Members and community organizations.

<u>Regular meetings</u> were held with community organizations to discuss collaboration.

Outreach activities were held at the Multicultural Council, St. Clair College, Hotel Dieu Grace Hospital, St. Joseph's High School, TRIOS Training School, and Alzheimer's Society.

The Butterfly Monument Ceremony – was presented on June 1, 2018.

Calls for information- more calls for referrals and services were processed due to increased awareness.

EDUCATION: New this year, BIAWE added another education program to its roster of events:

- **NEW** Brain Information and Concussion/Injury Prevention Program to middle school and high school students presented to Corpus Christi and Brennan High School Athletic Academy developing program to present to all high schools. Thank you, **Anna Jurak**, for your excellent work on promotion and presentation of this very important program.
- <u>GOALS: Peer Success Group</u> New coordinator- **Danielle Bridges** with facilitators **Renee Cantarutti** and **Robyn Craig** increased number of sessions from 6 to 8 per year and more in the county.
- Education Series Managing Your Emotions by Jenny-Lee Almeida, Strategies for Memory Problems by Shirley Lee, and The Power of Positive Thinking by Michelle Weglarz were presented.









The BIAWE Team continued its excellent educational programs with the following:

<u>Helmets for Kids</u> – 157 children were fitted and supplied with helmets in Windsor and Leamington through community agencies.
Children were instructed in the 2V1 method of fitting. Helmets were supplied by an anonymous donor and a \$1,000 grant from the **Bicycling Committee of the City of Windsor**. Thank you, **Leann Sassine**, for your work for community kids in need.
<u>Use Your Head Concussion Workshop</u> held at **Atlas Tube** on November 6, 2018 – *Theme: Are You Ready for Rowan's Law*?



SUPPORT: New this year, BIAWE added the following new services to support the BIAWE community:

NEW <u>Directory of Services</u> – online directory allows business and services to provide specific information about their business as it relates to survivors and families.

NEW Youth Support Group - Renee Cantarutti facilitating.

The BIAWE Team continued the following services:

Peer Support Program – Anna Jurak was trained by OBIA and is the Peer Support Coordinator.

<u>Social Group</u> – two volunteer organizers, **Christina Basily** and **Alesia Montemuri** organize social events of ceramics, painting, summer picnic, holiday dinner and monthly meetings at Hospice. Hospice underwent renovations and we were fortunate to use the Beyond Disabilities Room at **Hotel Dieu Grace Healthcare** for those two months.

<u>You Are Not Alone and Caregiver Support Groups</u> – Sessions are held monthly, include parents of children with ABI and are facilitated by **Sara Deluca Guarnaccia**

Volunteer Coordinator - new coordinator - Melanie Lopo has joined the Team.
